THIS INFORMATION SHOULD BE IN THEIR HANDS NOT LATER THAN AUGUST 15, 1951 IN ORDER THAT THE TENTATIVE PROGRAM MAY BE PRINTED AND CIRCULATED BY SEPT. 1ST. IT IS IMPERATIVE THAT PROMPT AND THOROUGH ACTION BE TAKEN IN ARRANGING THE TECHNICAL PROGRAM.
